

ANMODNING OM BERIGTIGELSE VEDRØRENDE TROELS GLUD: *Om renteforskelle og emissionspolitik på obligationsmarkedet.*

Straks efter udsendelsen af nævnte bog gjorde hr. cand. polit. H. Uldall-Hansen mig venligst opmærksom på en grov procentregningsfejl, som beklageligvis har foranlediget mig til fremsættelse af en urigtig påstand om, at højrentede obligationer falder forholdsvis mindre i kurs end lavrentede obligationer, dersom renten forhøjes. Fejlen findes på side 90, og der henvises yderligere til den urigtige påstand på side 106, 128, 202 og 209.

Samtidig med, at jeg meget må beklage denne fejl, takker jeg hr. Uldall-Hansen, fordi hans hurtige reaktion har gjort det muligt at bringe rettelsesbilag frem til de allerfleste, der har modtaget bogen.
