Usher, Dan: *The measurement of economic growth*. Oxford, Basil Blackwell, 1980. 306 pp. £ 17.50.

Bogen bygger delvis på tidligere afhandlinger af forfatteren, men fremstår i den foreliggende form som en afrundet fremstilling af problemerne ved at måle økonomisk vækst. Bogens første del er teoretisk, mens anden del indeholder nogle undersøgelser af specielle problemer baseret på empirisk materiale fra Canada i perioden 1926 til 1974. Bogen indeholder foruden en kompetent gennemgang af de tekniske problemer nogle overvejelser om hvad man ud fra en mere generel historisk eller politisk betragtning kan betragte som det mest hensigtsmæssige vækstmål. Konklusionen er, at det nærmest er et sprogligt problem og at det forekommer mest rimeligt at lade det tekniske fremskridt spille en mere fremtrædende rolle, end det har fået tildelt i de senere års empiriske vækstundersøgelser.
