I Hans Brems' artikel i Nationaløkonomisk Tidsskrift 1987, bd. 125, nr. 3, s. 287-98 er ved en beklagelig teknisk fejl en linie faldet ud på side 294. Tredje afsnit på side 294 skal lyde således:

Også i en åben økonomi som Danmark er altså Topps forestilling om en rentefod, der til enhver tid er under pengeautoriteternes

fulde kontrol og derfor kan udelades som tilpasningsvariabel, en illusion. Topp synes at være mere klar over sin forestillings svaghed i en åben økonomi, end han var over dens svaghed i en lukket økonomi.
