

## **BIBLIOGRAPHY OF SCANDINAVIAN POLITICAL SCIENCE, 1960-1964**

---

The present bibliography covers a period of five years. It contains, in addition to publications of native and foreign authors published in Denmark, Finland, Norway and Sweden; also publications of Scandinavian authors published in other countries; and publications dealing with the Scandinavian countries, wherever they have been published. The bibliography includes books, committee reports and other government papers, contributions to joint works, and periodical articles. Newspaper articles, however, needed to be omitted. Besides printed material, important mimeographed publications have also been included. Reviews of the books listed in the bibliography have been presented in connection with the respective books, but only reviews which appeared in periodicals have been included, not reviews published in newspapers.

Naturally it would have been impossible to present within reasonable limits of space a complete bibliography covering five years of political research and containing the literature published in, or dealing with, four countries. What follows below is only a selection. As far as books are concerned, the bibliography is, however, fairly complete. With regard to articles, the number of entries had to be greatly limited.

The presentation of the entries conforms rather strictly to the rules adopted for the International Bibliography of Political Science published by UNESCO. Accordingly, an English translation of a Danish, Finnish, Norwegian or Swedish title is presented in brackets after the original title. The scheme used in classifying the entries is also essentially the same as that used in the International Bibliography of Political Science, though somewhat simplified.

The entries relating to individual countries have been compiled and classified in the respective countries: in Denmark by Knud Vohn, in Norway by Helen Aareskjold and Stein Rokkan, and in Sweden by Sven Kinnander. Complete uniformity in principles concerning the selection and classification of the material has thus naturally not been attained. The undersigned has been responsible for the Finnish entries and for entries of publications regarding the Nordic Countries as a whole and published outside of them. It has also been my task to revise and technically unify the whole material and to supply the author index.

Many thanks are due to the collaborators in Denmark, Norway, and Sweden; to Henrik Schauman, Chief Librarian of the Finnish Parliament, who throughout the work has given invaluable advice; and to the editors of the present volume.
