

Bibliography of Scandinavian Political Science for 1974 and 1975

This bibliography is a review of Scandinavian political science literature for 1974 and 1975. There was no bibliography in *Scandinavian Political Studies* Vol. 10, and therefore this bibliography may be considered a continuation of the one published in *Scandinavian Political Studies* Vol. 9. We have included the following:

- (1) publications by native and foreign political scientists printed in Denmark, Finland, Iceland, Norway and Sweden,
- (2) literature by Scandinavian authors published in other countries, and
- (3) other publications which deal with central aspects of Scandinavian political life.

The bibliography includes books and contributions to joint works and periodicals. Mimeographed papers and reports have as a rule not been included here.

The different entries have been compiled and classified in their respective countries: in Denmark by Ole Hafstrøm, in Finland by Terttu Turunen and in Sweden by Bertil Nygren. The undersigned is responsible for the collection and classification of the Norwegian bibliography, as well as for the final editing of the bibliography. The national editors have sought to attain a high degree of uniformity in the classification of entries by following the classification scheme used in the International Bibliography of Political Science published by UNESCO.

We would like to thank our national editors for their co-operation, and also extend our thanks to Esther Nilsen for her much needed assistance. We are indebted to the editors of this volume for their co-operation, support and patience.
